

SPREWELL BLUFF PARK PAVILION RENTAL AGREEMENT

The Sprewell Bluff Pavilion agreement provides guidelines for the reservation of a pavilion in the day use area of Sprewell Bluff. The pavilions at day use area are available for use by non-profit organizations and individuals for civic, cultural, educational, and similar activities of a non-profit nature or for intergovernmental purposes. It is Upson County's intent to provide a meeting place for citizens of our community that will enhance the quality of life for community residents and visitors.

Rental Costs: Sprewell Bluff Park Pavilion

Pavilion Rental \$35.60 (on Reserve America)

Payment must be made at time of reservation to be placed on calendar.

Contract will be written and signed at rental & receipt given to renter as well as a copy of rental agreement if rental made in person at Sprewell Bluff Park.

Rental and reservation of pavilion is for general private recreational use.

Not intended to be for fundraisers or paying events since pavilion lacks power, lights, and amenities for large events.

Facility Rental

Groups WILL NOT leave equipment and facilities damaged or trashy. Renter will be held responsible. We ask that you help in keeping the area clean and pleasant for future groups. Please report any damage or broken items you might notice to Sprewell Bluff Trading Post or call 706-741-0041.

Please remember all buildings and facilities are **NO ALCOHOL & NO SMOKING VENUES.** Events will be cancelled if policies are not followed.

RULES AND REGULATIONS

All Functions must be family or community oriented.

No alcohol or drugs will be allowed on the premises.

No loud music that would prohibit other visitors' enjoyment of Sprewell Bluff Park.

1. All persons attending event/gathering at reserved pavilion must pay the \$5 per car parking pass to gain admission to park. Pavilion rental/reservation only covers the use of pavilion.
2. All persons utilizing the facility should exhibit common courtesy and respect for the rights of others.
3. Renter shall be responsible for pick-up of any trash.
4. No smoking shall be permitted at County properties.
5. No DJ'S allowed. Users of pavilion should not have loud music (ie: DJ and speakers) that would prohibit other visitors' enjoyment of the park.
6. Personal or rental equipment shall not be left overnight.
7. UTILIZATION OF FACILITY IS THE RISK OF THE USER. THE COUNTY ASSUMES NO RESPONSIBILITY FOR INJURY TO PERSONS ARISING FROM UTILIZATION OF THE FACILITY.

The following are strictly prohibited:

8. Illegal gambling or wagering
9. The carrying or discharge of any handgun, firearm, air gun, gas gun, spring operated gun, B.B. gun, or any other gun, slingshot, dart devices, or bow and arrow, except as any of the above may be specifically allowed by law.
10. The possession or discharge of fireworks or explosive devices of any kind.
11. Being drunk or disturbing the peace through riotous, boisterous, threatening, or indecent conduct, or the use of abusive, threatening, profane, or indecent language.
12. Defecating or urinating other than in a rest room
13. Use, consumption, or possession of alcoholic beverages.
